#### MARKETS AND SLAUGHTER-HOUSES (ESTABLISHMENT) ORDER, 1958

Made by the Minister under section 3 of the Markets and Cap. 265. Slaughter-houses Act.

1. This Order may be cited as the Markets and Slaughterhouses (Establishment) Order, 1958.

2. The under-mentioned places are hereby designated as public markets for the purposes of the Act:—

(i) The following place to be known as the Fairchild Street Public Market---

All that parcel of land situate at Fairchild Street, Bridgetown, containing approximately 63,000 square feet, bounded on the north by the Constitution River for a distance of 300 feet from the northernmost point of the eastern boundary of the lands of the Government now used as a bus terminus, on the west by the said lands of the Government now used as a bus terminus, on the south by the line of Fairchild Street for a distance of 300 feet from the southernmost point of the eastern boundary of the said lands of the Government, and on the east by other lands of the Government along a straight line drawn from the most easterly point of the northern boundary as determined above to the most easterly point of the southern boundary as determined above;

(ii) The following place to be known as the Cheapside Public Market—

All that parcel of land situate at Cheapside, Bridgetown, containing approximately 75,000 square feet, bounded on the south-east by the line of the guard wall standing on lands of the Government and known as the Bridgetown Fish Market and running from the sea to the public road which is the continuation of Hincks Street, thence along the same public road for a distance of 220 feet, thence along a line running in a south-easterly direction for a distance of

225 feet to the south-west wall of the building known as the Rum Bond; thence along the line of the south-west wall of the Rum Bond for a distance of 195 feet, thence in a straight line in a south-westerly direction to the sea; thence along the sea-shore to the guard wall forming the eastern boundary of the building known as the Bridgetown Fish Market;

(iii) The following place to be known as the Eagle Hall Public Market—

All that parcel of land formerly part of the land of a place called Bosvigo situate at the corner of Bank Hall Cross Road and Eagle Hall Road, Saint Michael, containing 13,778 square feet butting on two sides on lands of Bosvigo and on the other two sides on the public roads of Eagle Hall Road and Bank Hall Road respectively;

(iv) The following place to be known as the Speightstown Fish Market—

All that parcel of land situate at Speightstown, Saint Peter, containing approximately 9,380 square feet, bounded on the south by the Government sea-wall for a distance of 54 feet from the sea to the road, on the east by the line of Orange Street for a distance of 177 feet from the most easterly part of the sea wall, on the north by lands of the Government known as the Esplanade and on the west by the sea;

(v) The following place to be known as the Oistins Fish Market—

All that parcel of land situate at Oistins, Christ Church, containing approximately 5,265 square feet bounded on the east by a line to the boundary of Oistins Police Station from Oistins Road to the sea, on the south by the sea for a distance of 117 feet, on the west by the boundary of the property of C. S. Yarde and on the north by the line of Oistins Road;

(vi) The following place to be known as the Six Cross Roads Public Market—

All that parcel of land situate at Six Cross Roads, Saint Philip, containing approximately 30,720 square feet bounded on the north by the southern boundary of the lands of the Housing Authority for a distance of 120 feet from the point where such boundary meets Farm Road, on the west by the line of Farm Road for a distance of 324 feet from the most westerly point of the northern boundary as determined above, on the east by lands of the Government for a distance of 208 feet, and on the south by other lands of the Government for a distance of 158 feet.
